CIRCULAR

The Executive Council at its 269th meeting held on 18/09/2017 (vide Resolution No. 6.6) has considered the amendment in Clause 10.2(iv) of the House Allotment Rules of the University regarding increasing period of retention of government accommodation from one year to two years in case of death of allottee as per following details :-

10.2: Allotment of a residence shall come to an end automatically on the happening of any of the following events mentioned in col.1 below. The employee or his legal representatives, as the case may be, on their written request may be allowed grace period mentioned against each event in col.2 below, to vacate the premises. The grace period will not confer any right on the allottee/legal representatives as the case may be:	10.2: Allotment of a residence shall come to an end automatically on the happening of any of the following events mentioned in col.1 below. The employee or his legal representatives, as the case may be, on their written request may be allowed grace period mentioned against each event in col.2 below, to vacate the premises. The grace period will not confer any right on the allottee/legal representatives as the case may be:
