To The Sho Police Station Vasant Kunj, New Delhi-110067, Respected Sir, I am writing you to file an FIR against Mr. Buddha Singh who molested me, abused me publicly at Sabarmati Dhabha, JNU around 6 pm on 10th October 2017. He pushed me on my chest and made sexist remarks. On 10th October JNU Student Union protested outside IHA against the hostel raids in girls hostel which took place under the leadership of Buddha Singh. While the protest was going on in front of Dean of Students office (10th October 2017) an outsider person was caught by students taking pictures particularly of girls students. This man came out from the office of Buddha Singh. When we protested about the unauthorised intrusion and further questioned the concerned person asserted that he was friend of Buddha Singh. When students asked him to delete the pictures in his mobile he immediately ran away from the venue making suggestive remarks. I immediately updated the picture of Buddha Singh's friend with the details of the incident on Facebook. After the protest got over, I came back to my hostel Shipra and noticed that NAAC team was there in my hostel to talk to the residents of the hostel. I saw that Buddha Singh was accompanying them there as well. Many students along with me complained to the NAAC team against the harassment of girls students by Buddha Singh in past few days. The NAAC team assured us that they will look into the matter. Later on, in the evening around 6-7 pm at Sabarmati Dabha when we were sitting along with few other friends having tea, Buddha Singh came there along with few ABVP activists and start pointing finger towards me. These people started laughing at me. I initially ignored their suggestive gestures but they kept doing it. Since they continued doing the same I along with many other students started sloganeering. Many students started gathering with us and from the other side ABVP activists joined Buddha Singh. Few students started videographing the incident. To our surprise ABVP activists on the behest of Buddha Singh snatched away the phone of one of the boy making the video and threatened him to delete the video. This infuriated the students and many more students started raising slogans against the misbehaviour of Buddha Singh. Since I was continuously raising slogans against Buddha Singh he continued staring me and said "I am seeing you since morning bitch" and he pushed me by my chest. Many students came forward me to help me. Despite all this few ABVP activists, started laughing towards me and when I asked them to maintain the decorum they asserted that they will laugh and no one can stop them. We immediately called the JNUSU President Geeta Kumari. She called the police by dialling 100. Probably getting to know that police has been called the phone which was snatched earlier Buddha Singh returned the phone back. I thought of complaining that time itself but since the most credible body of our campus on such cases, GSCASH has been disbanded I let it pass. But later on, on 26th when I received a mail from proctors office I was shocked to see myself being implicated in an inquiry and accused when it was me who was being harassed. It was me who was on the receiving end of the entire episode so. I thought of filing an FIR. And after consulting my friends and family who gave me the courage and strength to file the complaint against Buddha Singh. I decided to take this matter with police immediately.
