The ICC has received a complaint forwarded to us from the police station Vasant Kunj filed by you against Dr. Buddha Singh. Dr. Buddha Singh appeared in front of the ICC sent you two notices to come and depose in front of committee, so that ICC can proceed and conduct an inquiry in this matter, but you did not come for the same.
