Dear Prof. Kumar

Filling up of teaching positions in Central Universities is an important issue which was discussed in the last two Visitor's Conference chaired by the Hon'ble President. In these Conferences, Vice Chancellors were exhorted to fill up the vacant position of teachers in a time bound manner. In the Parliamentary Committee meetings as well as in Parliament Questions, the issue of filling up of posts in the University has been repeatedly raised by the Members of Parliament.

- The Selection process for filling up of the faculty positions has been started by most of the Central Universities. However, it is understood that still some of the Universities are not able to fill up substantial number of positions lying vacant.
- In some of the Central Universities, the statutory post of Registrar, Finance Officer, Controller of Examinations etc. are also lying vacant.
- You are, once again requested to give this issue 'top priority' and take time bound action so that the vacancies of faculty positions including those belonging to SC/ST/OBC categories, as well as statutory posts are filled up early.

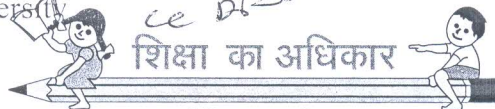
