1. दिनांक 09.02.2016 को जे.एन.यू. के कुछ छात्रों द्वारा साबरमती ढाबा पर सायं 5 बजे "CULTURAL EVENING" "AGAINST THE JUDICIAL KILLING OF AFZAL GURU & MAQBOOL BHATT" का आयोजन किया गया। जिसका पोस्टर परिसर में लगाया गया था। इस विषय पर पता चला कि आयोजनकर्ताओं ने डीन छात्र से पहले CULTURAL PROGRAMME की अनुमति ली थी। जब पोस्टर परिसर में लगाया गया तो छात्र सौरभ शर्मा, संयुक्त सचिव, जे.एन.यू. छात्र संघ ने इस विषय पर प्रशासन को लिखित में शिकायत दी। प्रशासन द्वारा तुरंत इस कार्यक्रम की अनुमति रद्द कर दी गयी। इसके मद्देनजर तुरंत ही सुरक्षा कार्यालय द्वारा वसंत कुञ्ज थाने को लिखित में सूचित कर दिया गया (पोस्टर और पुलिस रिपोर्ट संलग्न)।
2. आदेशानुसार करीब 1645 बजे सुरक्षा टीम मौके पर पहुंची। वहां पर उपस्थित छात्र उमर खालिद व छात्र अनिर्बान, को प्रशासन द्वारा कार्यक्रम अनुमति रद्द किये जाने के बावत समझा दिया गया। छात्रों ने माइक और पोस्टर लगाने की पूरी तैयारी की थी। पोस्टर लगा रहे थे लेकिन सुरक्षा कर्मियों ने पोस्टर और माइक नहीं लगने दिया। इस बावत इन छात्रों से काफी बहस बाजी भी हुई। बाद में वहां पर इक्कठे 50-60 छात्रों ने खड़े होकर नारेबाजी की। इनमें छात्र सैयद उमर खालिद निवासी 168 तासी छात्रावास, अनिर्बान भट्टाचार्या, 226 ब्रह्मपुत्रा मुख्य आयोजनकर्ताओं में थे। छात्रा श्वेता राज, आशुतोष. रामानागा, बनोज्योत्सना पूर्व छात्रा, अनंता प्रकाश, छात्रा ऐश्वरिया अधिकारी, मौजूद थे। भीड़ बढ़ने लगी छात्र उमर, अनिर्बान भट्टाचार्य वहीं पर खड़े होकर अफजल गुरु, मकबूल भट्ट जिंदाबाद, कश्मीर की आजादी तक जंग रहेगी जंग रहेगी, भारत की बर्बादी तक जंग रहेगी जंग रहेगी। जिस कश्मीर को खून से सींचा वह कश्मीर हमारा है, हम क्या मांगे आजादी, बन्दूक से लेंगे आजादी, गो इंडिया गो बैक, इंडियन आर्मी मुर्दाबाद, के नारे लगाये। तथा इनके साथी खड़े होकर ही कविता एव नाटक करते रहे। इनमें 2-3 लोगों ने मुह में कपड़ा बांधा था। इनके कार्य कलाप से ये बाहरी लोग लग रहे थे।
3. दूसरी तरफ 24x7 ढाबा के पास ABVP के 25-30 छात्रों ने इनका विरोध जताया। यह सिलसिला 1930 बजे तक चलता रहा। इसी बीच छात्र कन्हैया(अध्यक्ष छात्र संघ) भी इन लोगों के साथ शामिल हो गए। 1930 बजे कार्यक्रम समाप्ति पर ये के सभी छात्र, छात्राये, मुख्य सड़क की ओर आने लगे वहां पर दोनों पक्षों में नारे बाजी शुरू हुई। सहायक पुलिस आयुक्त तथा वसंत कुञ्ज थाना प्रभारी टीम के साथ उत्तरी द्वार पर तैनात थे। पी. सी.आर तथा पुलिस थाने की गाड़ीयां पहुंची थी। वहां से साथ साथ दोनों पक्ष गर्म जोशी के साथ गंगा ढाबा तक बढ़ने लगे। स्थिति को देखते हुए थाना प्रभारी टीम के साथ मौके पर पहुंचे। गंगा ढाबा पर छात्र कन्हैया कुमार(अध्यक्ष छात्र संघ) तथा छात्र रामानागा, अनिर्बान ने भाषण दिया और नारे लगाये। साथ ABVP के

The necessary permission may also be provided to the police force to enter the premises to take necessary steps and to use video coverage for covering the activities of such acts/expressions of sedition and anti-national speeches for legal action.

The faulty CCTV cameras of JNU campus be rectified and security staff be briefed to use available video cameras to record such event so that recording is available for the post incident analysis. You are also requested to install CCTV cameras at the entry/exit points and strategic locations in the interest of safety and security of the University Campus.

OFFICE ORDER NO. 115/CP/2016

Based on the report submitted by the Chief Security Officer, video clipping of the events and other related documents, the High Level Enquiry Committee, constituted by the Vice-Chancellor, JNU, is of the opinion that prima facie evidence of the occurrence of the following offences exists :-

- (i) Misrepresentation of the proposed event as a cultural evening although the objective was to hold a political meeting.
- (ii) Forcefully holding the event even when the permission to hold it was withdrawn by the DOS.
- (iii) Creating a law and order situation on campus both at Subarnati Hostel and Ganga Dhaba.
- (iv) Shooting unconstititutional slogans, and making derogatory remarks about the nation.

Prima facie, the Enquiry Committee finds the following individuals to be involved in one or more of the aforesaid offences :-

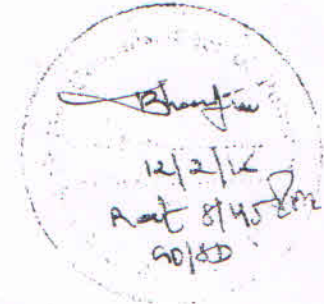

Dear Prof. Chandrasekhar,

Thank you for your email. As explained in the Dean's meeting and as you have correctly mentioned below "you are against having the police on campus, but that in this case your hands were tied because the police had claimed that the charge relating to the February 9th incident being 'sedition', it had the legal right to conduct investigations freely anywhere, including on campus", let me assure that the administration has never invited the police to come to the campus. At 10 PM on 10th Feb 2016, the DCP, Vasant Vihar contacted the security officer and sent a letter requesting the university to cooperate in providing the video and audio footage and other information as per law. The police also requested the authorities to allow the police to enter the university as an FIR has been registered against unnamed persons raising anti-India slogans on the campus on the charges of sedition, which is a serious criminal charge. We therefore gave permission to the police to investigate and act as per the law of the land. Registrar has confirmed that he has not commented at all about the endorsement which you have mentioned. We have in fact written a second letter to the police that while sharing the sentiments of the JNU community we trust that the police authorities will take all necessary precautions and due care in discharging their lawful duties so as not to disturb the normal functioning of the university system. Police have assured that they will not enter the campus unless circumstances so demand as per law.

I seek all your cooperation in making sure that the University gets back to regular academic activities as we all are committed to making JNU even better than what it is today.

Dear Prof Kumar

This is with reference to the Dean's Committee meeting held at 11 am in the morning on February 12th, which led to a position statement the university has issued. You would recall that in that meeting the issue of not allowing/inviting police into the campus was explicitly raised. You too declared that you are against having the police on campus, but that in this case your hands were tied because the police had claimed that the charge relating to the February 9th incident being 'sedition', it had the legal right to conduct investigations freely anywhere, including on campus. We did in good faith accept that explanation, also because at that time hostel searches of individual rooms without a warrant had not begun.

We have now been told by the JNUTA Executive and a large section of teachers that a delegation from among them that met you was:

1. Read out a letter from the police that explicitly asked for permission to enter the campus and conduct investigations.

2. Informed that the university replied to the police giving them the right to enter and conduct operations on campus 'as and when they deem fit', which we are told amounts to giving up the long term immunity from police entry into the campus without invitation that universities have.

If this is true, it amounts to a major change in the policy adopted by successive Vice-Chancellors ever since JNU was established, and against the policy that most universities adopt.

In addition, we have been told that the Registrar told the teachers' delegation that the Committee of Deans endorsed this decision of the University, which is patently wrong.

We would therefore request you to issue a clarification that the details with respect to this matter were not revealed to the Deans Committee, and the statement issued was not an endorsement of police presence and raids but only of the internal inquiry instituted by you as Vice Chancellor.

We also strongly urge you to find ways to immediately retract any blanket permission to the police to enter and conduct operations on campus.
